# **Board of Trustees Meeting**

# April 17, 2019 scheduled 7 to 9 PM

## Attendance:

**Proceedings:** Meeting called to order at 7:10 PM with opening words by Bill Benshoof

**Minutes** for the March meeting were approved in the meeting and have been uploaded to the BOT Google Drive.

**June Meeting Date Change:** Due to a conflict with UUA General Assembly and other member conflicts the June meeting will be held on Wednesday, June 5 7-9PM

## Visiting Member Discussion on Septic-Sewer Conversion and Related Topics.

Sue Ann expressed concern that the sewer connection wasn't the most serious problem we have. In particular, hole in the parking lot is more dangerous to children and exposes UUCG to possible liability for injuries.

Sue Ann also asked for more detailed information on the finances and potential costs.

Rev. Jan explained there is 39,449 on hand after endowment loan is delivered (\$3000 of this has already been spent on the project)

23,600 from loan cash-out has been moved to contingency reserves

If we go over \$50K expenses, BOT is obligated to go back to congregation before taking next steps

Sue Ann also asked about the linkage with Turning Sun. The need to move to a sewer connection was discovered as a result of the Turning Sun permitting process. However, UUCG would have to do it independent of the relationship with the school. Our septic system is not adequate for the

current building use and is beyond its expected life. A failure of the system would cause additional significant expense. There is no contingency in the contract, although Turning Sun will need to have the sewer to operate. This lack of a contingency is evidently not fully understood by all UUCG members and this needs better communication. (Rev. Jan mentioned that Heather may be able to come to an arrangement with the county if the sewer hookup is not completely done and operational when the school opens in August).

It is not known when the septic was last inspected or pumped. This suggests that we need to have a better tracking system for major maintenance items.

There was more discussion about the parking lot. Sue Ann is concerned that the hole will get larger. This is not likely since the root cause of the hole is known (abandoned well). How will we keep the Turning Sun children away from the hole? Turning Sun will be enclosing the playground.

Chuck Powell is seeking a minimum of three bids from contractors for the connection work.

Project management will transition to Dave McHenry on May 3 (Chuck is taking a full-time job)

Rev. Jan took two action items 1) contact Don G about getting a better barrier and 2) ask Don for better estimate of cost of repairing the hole.

**Bylaw Changes –** There was an open discussion about LDC, the nominating process and composition of the board. Katrina and Thomas asked if LDC could be renamed to Nominating Committee and focus on that task. A question came up as to who is responsible for approving the final ballot. Also briefly discussed was how we should elect BOT officers going forward. LDC will research this. Rev. Jan will send list of possible Bylaw changes to the Board and LDC. We could discuss these issues at next retreat (including LDC and BOT) probably in August.

**Next Town Hall will be April 28 –** will cover updates on sewer projects, election slate status as well as open discussion of idea for capital improvements.

**Partners in Ministry Award – Rev. Jan** will order 10 "rainbow" chalice pins. There are 8 award recipients. The awards will be made May 19. **Bill B.** will print certificates

**GA 2019 –** Need two more delegates. Nathalie tentatively agreed to be an off-site delegate. **Rev. Jan** will continue to search.

Eagle Scout Project - Landon Meyer will present his project proposal at the May BOT meeting

**UUA Program Fund Pledge -** The forms from the UUA have arrived. Board will discuss at May meeting

**"Capital" Campaign –** Rev. Jan has spoken to Dawn Cooley. We are not really considering a capital campaign but rather a drive to meet focused funding needs and this is not visionary. Need to form a small (3-5 members) team. **Rev. Jan** will make a "wish list" and distribute week of April 22.

**Cell Tower** – SBA contacted the church with an additional possibility for sale of the tower. UUCG could sell a 50% interest in the tower (half buyout) and still maintain some income from the property.

**Weekly Count & SignUp Genius (SUG)** – Specific Assignments were made in the meeting. However, people are still signing up independently as noted below.

# Minister's Report to the Board

#### Turning Sun & Sewer Project: See responses to questions submitted by Katrina Yurko

- Sewer Project:
  - Chuck, Dave, Marcus and I have weekly check-in calls on Wednesdays at 6:00, plus e-mail, text and/or calls as needed between check-ins
  - As of 4/17: (Marcus was not able to participate in the call)
    - Expect design plan from BLW by Thursday or Friday this week. This will include easement documents. Initial documents do not have any monetary exchange offered; hoping they will sign the easement without requiring compensation or, if not, that compensation will be minimal
    - Chuck has drafted a letter to accompany the easement documents that looks good to me; will get feedback from Marcus and set it up on letterhead for his signature
    - Chuck has contacted 7 contractors for initial conversations; as soon as design plan is received we can start getting bids:
      - 2 are willing to take the job
      - 1 has potential
      - 1 ruled out
      - 3 waiting to hear back

#### Information:

• SBA Tower: I received a call from SBA Towers on April 17. Our new account contact is Marypat Ciarletta, 561-226-9203, mciarletta@sbasite.com. We discussed the current state of clients on the tower (T-Mobile, MetroPCS, AT&T). MetroPCS bought by T-Mobile so MetroPCS may be removed at some point. She confirmed that anytime we want to request an offer for buying out the land-lease she will be the person to contact. Also, she told me that they offer half buyouts in which they buy out only a portion of the lease (about half), and the lessor continues to receive rental payments, but at a reduced rate (about half). This was news to me, and seems like a good piece of information to have in our pocket should a need arise.
